DECISION AND REASONS on Motion

This matter came on for a motion before a panel of the Discipline Committee on June 11, 2018 at the College of Opticians of Ontario ("the College") at Toronto.

The College brought a motion, with the consent of the former member, Stefanie Atyeo, for an order adjourning this matter indefinitely.

The Panel was provided with a copy of the Notice of Hearing, dated October 18, 2017, which set out the allegations against the former member. The allegations relate primarily to the former member's failure to cooperate with the College's Quality Assurance Committee.

In addition to the Notice of Hearing, the Panel received the former member's Acknowledgement and Undertaking, dated May 24, 2018, wherein she confirmed that she had resigned from the College and that she would not seek reinstatement in the future.

In light of the evidence presented, primarily the Acknowledgment and Undertaking, the Panel agreed to make an order adjourning this matter indefinitely.

Below are the panel's reasons for decision:

- 1. This motion was agreed to and brought forward jointly by the College and Ms. Atyeo.
- 2. Ms. Atyeo has entered into an Undertaking with the College to resign permanently and further she has agreed that she will not seek membership with this College again.
- 3. The Undertaking is consistent with the College's obligation to act in the public interest and to above-all, act in furtherance of public protection. Permanently removing Ms. Atyeo from practice meets the College's obligations.
- 4. The permanent adjournment, the Undertaking and these reasons shall form part of the public register and shall be available to members of the College and the public at large.
