**APPLICATION UNDER SECTION 87 OF THE *HEALTH PROFESSIONS
PROCEDURAL CODE***

ORDER

THIS APPLICATION, made by the Applicant, the College of Opticians of Ontario, for:

- (a) an interim and final order directing Tracey Watson and anyone employed by or otherwise acting on her behalf to comply with sections 4 and 9 of the *Opticianry Act, 1991* and section 27 of the *Regulated Health Professions Act, 1991* and, in particular, that Tracey Watson refrain from:
- (i) holding herself out as a person who is qualified to practise in Ontario as an optician, and
 - (ii) performing any controlled acts including dispensing subnormal vision devices, contact lenses or eye glasses and

- (iii) from aiding and abetting Karolina Doe, Sareese Doe and Chris Doe or anyone else from doing these acts.

and

- (b) an interim and final order directing Karolina Doe, Sareese Doe and/or Chris Doe to comply with sections 4 and 9 of the *Opticianry Act, 1991* and section 27 of the *Regulated Health Professions Act, 1991* and, in particular, that Karolina Doe, Sareese Doe and Chris Doe refrain from:
 - (i) holding themselves out as a person who is qualified to practise in Ontario as an optician, and
 - (ii) performing any controlled acts including dispensing subnormal vision devices, contact lenses or eye glasses.

and

- (c) an interim and final order requiring Tracey Watson to disclose to the applicant the:
 - (i) full name and known contact information for Karolina Doe, Sareese Doe, and Chris Doe; and
 - (ii) the personal address of Karolina Doe, Sareese Doe, and Chris Doe.

and

- (d) its costs on a substantial indemnity basis together with applicable Harmonized Sales Tax.

was heard this day at 393 University Avenue, Toronto, Ontario.

ON READING the Application Record of the Applicant and the Consent of the parties, filed, and on hearing the submissions of counsel of the College of Opticians:

1. **THIS COURT ORDERS** that the Respondents, Tracey Watson, Karolina Osypiuk, Cerise McKay, and Chris Kennedy shall comply with the *Opticianry Act, 1991* and the *Regulated Health Professions Act, 1991*, and, in particular:
- (i) Ms Watson and anyone employed by her or otherwise acting on her behalf shall not hold him or herself out as a person who is qualified to practise in Ontario as an optician unless he or she is an optician member registered in good standing with the College of Opticians of Ontario;
 - (ii) Karolina Osypiuk, Cerise McKay, and Chris Kennedy shall not hold him or herself out as a person who is qualified to practise in Ontario as an Optician unless he or she is an Optician member registered in good standing with the College of Opticians;
 - (iii) Ms Watson and anyone employed by her or otherwise acting on her behalf shall not perform the controlled act of dispensing unless he or she is a member registered in good standing with the College of Opticians of Ontario, College of Optometrists of Ontario or College of Physicians and Surgeons of Ontario or the act of dispensing has been lawfully delegated in writing to that person by a member of one of those Colleges;
 - (iv) Karoline Osypiuk, Cerise McKay and Chris Kennedy shall not perform the controlled act of dispensing unless he or she is a member registered in good standing with the College of Opticians of Ontario, College of Optometrists of Ontario or College of Physicians and Surgeons of Ontario or the act of dispensing has been lawfully delegated in writing to that person by a member of one of those Colleges and
 - (v) Ms Watson shall not hold out any person employed by her or otherwise acting on her behalf to be an optician except where such person is an optician member registered in good standing with the College of Opticians of Ontario.

THIS COURT ORDERS that the Respondent, Tracey Watson, pay to the Applicant, the College of Opticians of Ontario, the costs of this application fixed in the amount of \$2,000.00 payable within 30 days.


