**ORDER**

**THIS APPLICATION** was heard orally this day,

**ON READING THE NOTICE OF APPLICATION**, the Affidavit of Tania Buko, the Affidavit of Dean C. Benard, the Affidavit of Stephen King, the Affidavit of Nitasha Nanda, the Affidavit of Munaverali Gulamhusein, the Affidavit of Rebecca Zaretsky and the Certificate of the Registrar of the College of Opticians of Ontario and upon reading the Consent of the parties, filed,

**THIS COURT ORDERS THAT:**

1. Chelcia Pratt, Athena Chaltas and Jordana "Jordy" Gomez immediately comply with sections 4 and 9 of the *Opticianry Act, 1991* and section 27 of the *Regulated Health*

*Professions Act, 1991* and, in particular, that Chelcia Pratt, Athena Chaltas and Jordana "Jordy" Gomez immediately cease and desist:

- (i) holding themselves out as a person who is qualified to practise in Ontario as an optician unless they are authorized to do so; and
  - (ii) performing any controlled acts including dispensing subnormal vision devices, contact lenses or eye glasses unless they are authorized to do so;
2. Chelcia Pratt and/or Spectacular Eyewear Inc. comply with section 42 of the *Regulated Health Professions Act, 1991* and, in particular, that Chelcia Pratt and/or Spectacular Eyewear Inc. immediately cease and desist employing any person who performs controlled acts unless the person is a member authorized by a health profession Act to perform the controlled act or the performance of the controlled act has been properly delegated to that person;
  3. The Respondents consent to the order as a whole (but for the costs issue as against Chelcia Pratt only which will be addressed on the court date set out in the Notice of Application); and
  4. Chelcia Pratt provide all contact information for the employees of Spectacular Eyewear Inc.
  5. Chelcia Pratt to pay to the Applicant its costs of this application on a - partial indemnity basis, fixed in the amount of \$ 7,500

**THIS ORDER** bears interest at the rate of 3 per cent per year commencing on February 3, 2014.
